### <u>Course Objectives – Objectifs du cours :</u>

The purpose of the course is to trace the history of trade within and between families and communities, beginning in prehistoric times and continuing up to the present day. Although most of the material will focus on the history of trade itself, we shall also look at the history of *ideas* about trade, from those of classical writers such as Herodotus through Ibn Khaldun, Adam Smith, David Ricardo through to researchers in the second half of the twentieth century.

We will consider how trade has interacted with subsistence base, migration, slavery, warfare, innovation, disease, the rise of the nation state, industrialization and political change. In short, most of the important developments in human history have been influenced by, and have had an influence on trade.

#### Prerequisites - Pré requis :

There are no prerequisites other than a course in intermediate microeconomics.
